- Doors will open at 8 AM for the teams, 8:30 AM for spectators. Enter the SHS Fieldhouse through the south east entrance - Door #1 (Main Entrance).
- 2. Admission for all day will be \$6 for adults and students.
- 3. Locker Room Assignments will be assigned upon arrival.
- Showers and locker rooms will be provided for all teams; however, you must provide your own towels.
 We will provide warm up balls, but feel free to bring your own.
- Official scorers and timers will be provided at all the matches. <u>However, teams are responsible for your libero tracker and one line judge.</u>
- 6. Before each team's first match, they will be allotted the 17-minute (State Rule) warm-up. Before the other matches, each team will have 3 minutes of net time.
- 7. A coin toss shall be conducted prior to each match to determine the home team. The visiting team will call the coin toss to determine the serve for Game 1. For Game 3, the home team will call the coin toss to determine the serve.
- 8. All matches will be the best 2 of 3 games to 21 with a deciding game to 15. All scoring is rally scoring with no caps. Each team will have two time-outs per game.
- 9. The tournament champion will be determined by Pool Play followed by winning the bracket.
 - a. In the event of a tie when separating into brackets tie's will be determined by: 1.
 Overall Record 2. Head to Head competition 3. Fewest points allowed during the day.
- 10. The concession stand will be open all day. If coolers are brought by your team, please keep in your team camp/locker room. NO COOLERS WILL BE ALLOWED ON THE GYM FLOOR.
